

## CUSTOMERS PRIVACY POLICY

### INFORMATION IN ACCORDANCE WITH ARTICLES 13 AND 14 EU. REG. 679/2016 (European Regulation on the Protection of Personal Data)

Dear Customer,

This statement shall be made in accordance with articles 13 and 14 of GDPR 679/2016.

**1) IDENTITY AND CONTACT DETAILS OF THE OWNER:** The owner and data controller is the company MARMOTEX SRL, with registered office in 37020, Volargne di Dolcè (VR), Via Sottomori 736, Vat Code 01433720339 and the person in charge of protection is Mr. VITTORIO RIGONI, contactable by e-mail: info@marmotex.it.

#### **2. FINALITY OF THE TREATMENT:**

**A) Administrative-accounting purposes:** Execution of the contract of which you are part, accounting and fulfilment of the obligations of law, after-sales services. The legal basis for this treatment is: execution of a contract of which you are a party. The data collected for this purpose will be retained for the duration of the contractual relationship and for 10 years after the termination of the same.

For the purposes referred to in point above the owner and data controller may collect and process the following personal information: personal data: first name, second name, surname, telephone number and e-mail address.

**B) Only with your consent, for marketing purposes:** or for sending of advertising material or direct sales, the completion of market research or commercial communication also personalized with automated contact modalities (e-mail, newsletters) and traditional (paper mail). The legal basis for this treatment is: your consent. The data collected for this purpose will be retained until the withdrawal of your consent. In addition to these personal data, the owner and data controller may also collect and process the following personal data relating to your profile and preferences: data collected during the visit to the showroom or during fairs, data collected during the navigation and/or use of the owner and data controller's website by using, for example, cookies or information about the pages that have been visited or searched. We do not possess, nor are required, any data qualifying as "particular" or "judicial" in accordance with the definitions of the said regulation.

**3) RECIPIENTS OF THE DATA:** The personal data processed will not be disseminated but communicated to well-defined subjects. On the basis of the roles and job duties carried out, the internal and external personnel are entitled to the treatment within the limits of their competences and in accordance with the instructions given to them by the owner. The same data may be communicated to subjects entitled to access them under legal provision and regulations, to correspondence delivery companies, BANCGE, credit institutions, law firms, insurance companies, computer equipment maintenance companies, professional studies, companies providing accounting services, tax service, fiscal services, self-employed/occasional, agents.

**4) DATA TRANSFER:** The owner and data controller does not transfer personal data to third countries, but reserves the right to use services in the cloud, and in this case the service providers will be selected from among those providing adequate guarantees, as laid down from art. 46 GDPR 679/2016.

**5) CONSERVATION OF DATA:** The owner and data controller of the treatment preserves and treats the personal data for the time strictly necessary to fulfil the purposes indicated or for the period imposed by the current provisions on civil and taxation matters.

**6) RIGHTS OF THE PERSON CONCERNED:** Pursuant to CP III of Regulation (EU) 2016/679, you may at any time request information on your personal data, processed by the owner and data controller (right of access), and request any integration, rectification or cancellation and opposition. In addition to these rights, you may also exercise the following rights: limitation of treatment, portability of data and proposal for a complaint to the

**7) CONFERRAL OF THE DATA:** The conferral of the data is obligatory on the basis of compliance with the law, regulations and conditioning the possibility to fulfil correctly and effectively the contractual obligations assumed, therefore an eventual refusal to conferral will result in the impossibility of fulfilling the contractual obligations, sending advertising material and performing promotional activities.
