

PRIVACY POLICY

Dear Guest,

first we would like to thank you for visiting us. We give a lot of value to the fact that you can trust us and therefore we wish to share with you in this page the finalities and the formalities of treatment of the personal data that we pick up during your navigation, following your possible mailing list or newsletter registration. The treatment of your personal data always keep the standards of lawfulness and correctness in compliance to all the in force normative applicable. Following, you will find all the details on the treatment of your personal data.

1) IDENTITY AND CONTACT DETAILS OF THE OWNER: the owner and data controller is the company MARMOTEX SRL, with registered office in 37020, Volargne di Dolcè (VR), Via Sottomori 736, Vat Code 01433720339 and the person in charge of protection is Mr. VITTORIO RIGONI, contactable by e-mail: info@marmotex.it.

2) TREATMENT PURPOSE AND JURIDICAL BASE: Your personal data will exclusively be processed for the following purposes subject to your prior consent to the treatment, that can be revoked at any time according to the procedures time by time indicated by the owner in the occasion of the collection of the consent:

a) Management of the answers to your requests: You can decide to give the consent to the treatment of your personal data for the management and reply, by Marmotex Srl, to your request with reference to products, events and quotations. With reference to this purpose, your consent is requested at the moment of the submission of your requests. In case you decide not to give the consent to the treatment of your personal data for the aforesaid finality, it won't be possible to continue with the submission of your application.

b) Receipt of newsletter: You can decide to subscribe, giving the relevant consent, to newsletter service dedicated to you. With reference to this purpose your consent is requested during the registration to the service of newsletter.

Besides, also in absence of your consent, Marmotex Srl can treat your personal data for the:

- management and execution of the formalities provided by law (for fiscal, administrative and accounting purposes);
- complaints and possible disputes management (as legitimate interest of the owner).

3) RECIPIENTS OF PERSONAL DATA: The personal data processed will not be disseminated but communicated to well-defined subjects. On the basis of the roles and job duties carried out, the internal and external personnel are entitled to the treatment within the limits of their competences and in accordance with the instructions given to them by the owner.

4) DATA TRANSFER: The owner and data controller does not transfer personal data to third countries, but reserves the right to use services in the cloud, and in this case the service providers will be selected from among those providing adequate guarantees, as laid down from art. 46 GDPR 679/2016.

5) MAINTENANCE OF THE DATA AND PLACE OF THE TREATMENT: The owner of the treatment preserves and tightly draws the personal data at his own base and premises for the necessary time to carry out the suitable finalities, or for the period imposed by the in force dispositions in civil and fiscal matters. The owner of the treatment has adopted safety measures suitable to the risks that could derive from loss, destruction, change, non authorized disclosure, accidental or illegal access, abuse or alteration of your personal data.

6) THE PARTY'S RIGHTS: Pursuant to CP III of Regulation (EU) 2016/679, you can require at any time information on your personal data, object of treatment by the owner (access right), as well as ask for its possible integration, rectification or cancellation and opposition. Besides the aforesaid rights, you can also practice the following rights: limitation of the treatment, portability of the data and proposal of claim to the
